

ENTRY AND RELEASE OF LIABILITY FORM

In return for being allowed to participate in the Peter Piper Pizza Sun Bowl Punt, Pass & Kick competition, (collectively, the "Event"), I release and agree not to sue Pizza Properties, Inc., Peter Piper, Inc., the Sun Bowl Association, the University of Texas at El Paso, El Paso Parks and Recreation its members and their respective subsidiaries, affiliates, employees, subcontractors, sponsors, licensees and agents (collectively, the "Releasees"), from all present and future claims that may be made by me, my family, estate, heirs, or assigns for property damage, personal injury, or wrongful death arising as a result of my participation in the Event, wherever, whenever, or however the same may occur even if caused by a Releasee's ordinary negligence. I understand and agree that those listed above are not responsible for any injury or property damage arising out of the Event. I understand that participation in the Event involves certain risks, including, but not limited to, serious injury. Exposure to covid-19 which may exist in any public place where people are present. Covid-19 is an extremely contagious disease that can lead to severe illness and death. According to the centers for disease control and prevention ("CDC"), senior citizens and those with underlying medical conditions are especially vulnerable. by entering the Event grounds, participants voluntarily assumes all risks related to exposure to covid-19.

I am voluntarily participating in the Event with knowledge of the danger involved and agree to accept all risks of participation. I also agree to indemnify and hold harmless those listed above for all claims arising out my participation in the Event and all related activities including, but not limited to, first aid and/or other medical treatment.

I understand the Event may be photographed, videotaped or otherwise recorded, I agree to let the Releasees use my name, photo likeness, and demographic information free of charge in any manner and for any purpose in any media now known or hereafter created. I consent to the administration of first aid and other medical treatment in the event of injury or illness. I understand that this document is intended to be as broad and inclusive as permitted by the laws of the state in which the Event is taking place and agree that if any portion of this Agreement is invalid, the remainder will continue in full legal force and effect. I further agree that any legal proceedings related to this waiver will take place in El Paso, Texas, using Texas law.
